**RE:** Revised Grant Allocations for 2018-19 (FY 2019)

In April 2018, the Negotiated Rule-Making Committee made changes to the Texas Administrative Code (TAC) for each grant program in the Allocation and Disbursement of Funds section. These changes allow unencumbered funds in the first year of the biennium (FY 2018) to be carried forward for institutional use in the second year of the biennium (FY 2019). In addition, the changes to the rule guided the agency's approach regarding funds returned by institutions.

Enclosed are the revised TEXAS Grant, TEOG, and TEG Program allocations for FY 2019. The revised allocations include funds returned by institutions between April 1, 2018 through August 1, 2018. The returned funds have been carried forward to FY 2019 and have been added to these institutions' FY 2019 revised allocations. The redistribution of unencumbered FY 2018 program funds is based on each institution's calculated share, as stated in rule. Institutions have until **August 1, 2019** to request funds.
