**RE:** 2019-20 Bilingual Education Scholarship Final Allocation

This memo is to announce the enclosed 2019-20 final allocation amounts based on the appropriation from fiscal year 2020 for the Bilingual Education Scholarship program.

Institutions participating in the Bilingual Education Scholarship program are required to use funds **only** for grants to provide financial incentives in the form of tuition assistance. The program aims to encourage students who enroll in an educator preparation program at the university to become certified to teach bilingual education, English as a Second Language, or Spanish in school districts with high critical needs.

Disbursements for Bilingual Education Scholarship funds will require an institution to submit a funds request form as early as **August 1, 2019** and payment for these requests will be processed after the first day of the new fiscal year, September 1, 2019.
