RE: 2019-20 (FY 2020) and 2020-21 (FY 2021) Texas Educational
Opportunity Grant (TEOG) Final Allocation

This memo is to announce the enclosed 2019-20 (FY 2020) and 2020-21 (FY 2021) final allocation amounts based on the appropriation from fiscal year 2020 and 2021 for the TEOG program.

On April 4, 2019, the 10-day allocation data review materials were issued to institutions for the TEOG program. Institutions were invited to confirm that the "TEXAS Grant Preliminary Allocation Calculation Data" accurately reflected the data submitted to the Texas Higher Education Coordinating Board (THECB). Institutions were allowed 10 days to review the data which ended on April 18, 2019. Through this process, THECB received no comments about the data.

Institutions participating in the TEOG program will have the opportunity to submit an online funds request form for FY 2020 as early as **August 1, 2019**, and payment for these requests will be processed after the first day of the new fiscal year, September 1, 2019.
